- Enrollment Report
  - EVC/NRP movement of class rooms

  - Funding for magnets changed and less is from districts expenses
- Division Directors' Report
  - Grant awards totaled 3.7M this year
  - Marketing is revamping all of our materials to align with the strategic plan; new logo and branding in September
  - Leading and learning is now ACCESS and kicking off to a strong start
  - Collaborating with the CES on Multi-Tiered Systems of Support (MTSS)
  - Early Childhood is working on a community garden
  - Partnering with TVCCA for workforce development grant, in partnership with EWIB to increase people eligible to work in our programs through training
  - Transportation Hack-a-thon data being worked through to come up with innovative ideas

  - Lots of fluctuations in staffing numbers due to movement within agency; NRP is an example
