Called to order at 5:17 pm by Eric Protulis

Eric and Brian presented to the Board FY25 Budget Revision Process:

- Updates on conversations with finance committee about the current year budget outlining thinking and processes
  - Priorities include a break-even budget for this year, consider impact on existing programs and minimize impact to our districts
- Working with Division Directors reviewing the current year budget looking at both revenue and expenses
- After reviewing all the data and compiled all the information we still had a shortfall in FY25 budget of \$3.5
   million
- Looked at revenue projections in past years saw growth in revenue but expenses rose at similar or higher rate than projected revenue
- This year, fewer vacant positions increases costs
- Discussion around transportation and the building that the department is housed in
- Debt has accrued over the past 7 years from decisions of prior administration



- Strong revenue growth but the expenditure growth was missed over the past 5-6 years; including structural flaws in the budget development such as not including the RESC fee.
  - Fell behind with ECHIP because the formulas were not calculated correctly by previous administration
- The \$1.3 million is not inclusive of the ECHIP debt should be close to \$1m mark in January
- Action Taken:
  - Freezing Extra Duty
  - o Freeze hiring; all recommendations for hire are reviewed by Eric, Brian and Melanie
  - o Eliminate open positions
  - Delaying projects into next fiscal year
  - Calculate the health care costs and employee contributions and offer an equitable plan that is affordable to all employees
- Discussion items:
  - Discussed furloughs and reduction in force and other options
  - o Challenges about the restructuring of the budget to create a more accurate picture
- Review of re-structuring of the Hampton mortgage
- Furlough Days and Voluntary Pay Reduction Plans
- May propose mid-year rate increases with districts
